Part A: Pupil premium strategy plan

Statement of intent

We want all pupils, irrespective of their background or the challenges they face, to make good progress and achieve high attainment across all the curriculum. The focus of this strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our strategy is also integral to wider school plans for education recovery, notably in its targeted support through school-led tutoring for pupils whose education has been worst affected, including non-disadvantaged pupils.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Gaps in Learning Although the number of pupils is not significant in each year group, our internal assessments in the core subjects among disadvantaged pupils is below that of non-disadvantaged pupils.

2	Emotional, social and behavioural issues for some disadvantaged pupils continues to be important to invest in, in order to raise their attainment. These findings are supported by national studies.
3	Vocabulary gap for some disadvantaged pupils Some disadvantaged pupils have underdeveloped oral language skills – based on assessments, observations and discussions with pupils.
4	Attendance/Punctuality of some disadvantaged pupils is lower than non-disadvantaged peers. Data indicates that attendance has improved but remains lower than for non-disadvantaged pupils.

Intended outcomes

This explains the outcomes we are aiming for by the end of our current strategy plan, and how we will measure whether they have been achieved.

Part B: Review of the previous academic year

Outcomes for disadvantaged pupils

This details the impact that our pupil premium activity had on pupils in the 2022-2023 academic year.

50% of pupils eligible for Pupil Premium met the expected standard for reading, writing and maths at the end of KS1. There were six PP pupils in this cohort, two with SEND (EHCPs) and one child who joined our school on 18 April 2023 with 48% attendance at the previous school that academic year.

Overall, whole school attendance (93.11% compared to 93.8%) was broadly in line with the national average. Attendance for the disadvantaged pupils was above the national average (93.78% compared to 91.3%). However, absence amongst some disadvantaged pupils was higher than their peers which is why attendance remains a focus of our current plan.

Pupil premium funding has been used to provide targeted wellbeing support for all pupils, and interventions where required. We continue to build on that approach with the activities detailed in this plan.
